GENERAL RELEASE FROM LIABILITY

In consideration for the use of the facilities of Green Head Hunting Club, including the use of firearms on the premises, which Releasor expressly recognizes to be a dangerous activity, Releasor, for himself or herself, his or her spouse, legal representative(s), heirs and assigns, hereby releases, waives and discharges Green Head Hunting Club, its officers, members, owners and employees (referred to as "Releasees") from all liability to Releasor, his or her spouse, legal representative(s), heirs and assigns, for any and all loss and damage and any claim of damages resulting therefrom on account of injury to Releasor's person or property, even injuries resulting in death of Releasor, whether caused by the passive or active negligence of Releasees or otherwise, while Releasor is using the premises or facilities of Green Head Hunting Club.

Releasor agrees to indemnify Releasees, and each of them, from any loss, liability, damage, or cost they may incur due to the presence of Releasor in or upon the premises and facilities of Green Head Hunting Club, whether caused by the active or passive negligence of Releasees or otherwise.

Releasor hereby assumes full responsibility for the risk of bodily injury, death or property damage due to the active or passive negligence of Releasees or otherwise, while upon and using the premises and facilities of Green Head Hunting Club.

Releasor expressly agrees that this release, waiver and indemnity agreement is intended to be as broad and inclusive as permitted by the laws of the State of California, and if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full force and effect. Releasor hereby expressly represents that he/she is knowledgeable in basic firearms safety.

SAFETY RULES & REGULATIONS

Think Safety at All Times:

1. Treat all firearms as if they are loaded.
2. The safety of shooters, range personnel, and spectators requires self-discipline on the part of all participants.
3. Eye and ear protection is mandatory for everyone using the trap, skeet, five-stand, sporting clays, or rifle ranges.
4. Keep the muzzle of the firearm under control and pointed in a safe direction at all times.
5. Keep the actions of all firearms open except when on the firing line and ready to fire.
6. Alcoholic beverages shall not be consumed or be present in the shooting area.

All injuries of any type must be immediately reported to the Club Manager, who shall make a written record of the incident.
